SB 721: for those of you who have multifamily, two story buildings, the inspections of the outside stairs and balconies will be done in April. The cost will be \$800.00. You should be getting a letter from your Property Manager with more information. This is mandatory by state law.

Sewer bills: Most of you pay sewer bills quarterly. There will no longer be a quarterly bill mailed out from Monterey One Water. As you know, property tax bills run July 1-June 30. As of this tax year (2024-25) the full year sewer bill will be included in the property tax bill.

If you own commercial property and the tenants pay the sewer bill, they will still be expected to pay monthly, and that amount will be adjusted with each years bill. Note we will not hold these payments and they will be given to you along with your monthly distribution.

Please remember if we have paid your sewer invoice in the past you will no longer see this charge on your statements. Plan accordingly.

Pre-moveout inspections: We have always offered pre-moveout inspections to tenants, as required by California law but have not required a document refusing such inspections. With the new paperwork, their signature will be required and we expect to have more tenants requesting
